**ELECTION OFFICE REPORT**  
**May 26, 2021**

**Administration:**

- MAEO conference will be an in-person, if the COVID numbers are stable, on August 22 – 27, 2021 in Ocean City at the Clarion Hotel.
- We are still waiting for the FY22 budget approval.
- Kim and I will meet with Cynthia Thomas from the Office of the State Prosecutor about two double voters we had in the 2020 Presidential Primary Election on June 2, 2020

**Staff Updates:**

- Stephanie will be having surgery May 20<sup>th</sup> and will be working from home and in the office when able.
- Vanessa will be retiring as of June 1<sup>st</sup>.
- The reclass paperwork for Vanessa's position will be submitted June 2<sup>nd</sup>.

**Election Operations:**

- We have reviewed our equipment allocation for the polling place and believe we have enough equipment to cover our current precincts, however we submitted a request for pricing of additional equipment due to the possible impact of redistricting.

**Election Judges:**

- The Judge Department met with the rest of the staff to discuss the notes from the Lessons Learned Focus Groups. We compiled all the notes and will be sending out a follow-up email with the information we gathered for all of the judges to have.
- Loralyn and Sarah are cleaning up the Election Judge Main Information Sheet in preparation of the 2022 Election.
- Organizing and prepping the Pack Room is next on the list to begin preparing for the election.
- Daily judge work continues - emailing potential new judges, importing judge data and changes, phone calls and emails.

**QUORUM:**

Ms. McCord called the meeting to order at 5:00 p.m. and determined there was a quorum with at least one member of the minority party being present. This meeting was held in-person. There was also a video link available.

**WELCOME GUESTS:**

Maggie Mundle, Loralyn Sisler and Rich Siejack from the staff were in attendance to the meeting.

**APPROVAL OF MINUTES:**

Ms. Bopst motioned to approve the March 24<sup>th</sup> regular session minutes and Mr. Dykes seconded. The minutes were approved unanimously.

**ADDITIONS OR CHANGES TO THE AGENDA:**

FY22 Budget and the Board President's Coalition were added to new business.

**ELECTION OFFICE REPORT:**

**Ms. Taylor gave the Administrative update.**

**BOARD ATTORNEY'S REPORT:**

The case concerning Ms. Livingston is waiting for the court to reach a decision. Ms. Livingston can appeal this decision to the Court of Appeals, if she chooses.

The case concerning the settlement for Ms. Remmey will be discussed in closed session.

The State and County are still working out the details of the office lease.

**OLD BUSINESS:**

There was none to report.

**NEW BUSINESS:**

Ms. Taylor explained the office was not going to be fully funded in FY22. In the Space and Real Estate Rental subcategory, the office was flat funded from FY21. This is not enough to pay for the rentals we will need for the 2022 Gubernatorial Election. Another subcategory that falls short is Payments to Other Government Agencies, where the staff are being paid. With the upcoming Gubernatorial Election, more funding is needed to pay required overtime as well as having precincts, rather than vote centers, to staff. There are currently two staff members that need to be reclassified as well as reclassing the Director and Deputy Director. When the State worked on reclassing all Election Staff, they failed to realize that many of the IT Staff were making the same salary, if not more than the Deputy Directors. The County wants to wait until May 2022 to make any changes in the budget, however the budget needs to reflect the changes because of the known issues. The County said they would absorb the cost for the new pollbooks (approx. \$95,000) and that Facilities could incur the addition funds (approx. \$4,000) for Space and Real Estate Rental. Ms. Taylor asked for this in writing, and we have not received any correspondence from the County. Ms. Taylor also explained that the office is overbudget this year as well. Our budget has remained the same for the past 2-3 years. There is a spending lockdown currently in the office and only essentials being purchased. Ms. Taylor explained she will provide packets to the County Council to include recent election laws passed. It will also include the original request and a letter sent to County Executive Barry Glassman explaining increases to subcategories. Ms. McCord explained the General Assembly Fiscal Notes for each election law passed would also be helpful. Ms. Taylor explained the process of mailing of approximately 188,000 applications and the steps to process just one application are time consuming. Mr. Siejack added that Fiscal Notes are usually conservative. Ms. McCord suggested Board Members also be in attendance at the County Council to show support for the office.

Ms. Taylor asked about the newly formed Board President's Coalition. She expressed that many of the LBE Directors were upset. Ms. McCord explained they were an informal affinity group

with a common interest and was initiated as a result of Mr. Campbell's suggestion. The Coalition was formed to share information with each other. Ms. McCord said they were separated by the pandemic, had no information from MAEO, and they did not have a contact list of other Board Presidents. Mr. Voelp, SBE President, was also informed of the first meeting they held last week to share experiences. Mr. Campbell told Ms. McCord he had a contact list of the LBE Board Members.

Ms. Taylor explained that State Offices are still closed to the public, but some Boards are opening the monthly Board meetings to the public.

**CONFIRMATION OF NEXT MEETING:**

The next meeting will be held on May 26, 2021 at 5 p.m.

**MEMBERS TIME:**

Ms. Bopst attended the Republican Alliance event on March 31<sup>st</sup>, the Harford County Republican Women event on April 17<sup>th</sup> and the Republican Alliance meeting on April 26<sup>th</sup>. Ms. Bopst donated \$62 to Congressman Andy Harris on April 7<sup>th</sup> and \$100 to Delegate Mike Griffith on April 16<sup>th</sup>.

Ms. McCord attended the Republican Alliance meeting on March 31<sup>st</sup>, a fundraiser for Sheriff Jeff Gahler on April 23rd for \$100, the MD Federation of Republican Women Spring Meeting on April 24th for \$45, and the Republican Alliance Meeting on April 26th.

**CLOSED SESSION:**

Mr. Price motioned for a closed session under statutory authority #7 to consult with legal counsel to obtain advice on a legal matter. Mr. Campbell seconded the motion it passed with a unanimous vote. The closed session began at 6:01 p.m.

**ADJOURNMENT:**

Mr. Dykes made a motion to adjourn the meeting and Mr. Price seconded. The meeting adjourned at 6:23 p.m.
